CONCERN RISING WITHIN AMATEUR RADIO COMMUNITY OVER WWV SHUTDOWN PROPOSAL

It is our sad duty to report

ARRL members and Amateur Radio clubs are expressing increased concern over the inclusion of WWV and WWVH on a list of proposed cuts in the White House's National Institute of Standards and Technology (NIST) Fiscal Year 2019 budget request. The proposed cuts, which only recently came to light, would also include the Atomic Clock signal from WWVB. Online petitions soliciting signatures include one established by Tom Kelly II, W7NSS, of Portland, Oregon, who would like to see funding for the stations maintained. The decision is up to Congress.

"It is important to note that no changes to NIST services have occurred, and if the proposal were to be implemented, public notice would be provided," NIST said this week.

ARRL is suggesting that

members of the Amateur Radio community who value the stations for their precise time and frequency signals and other information sign the petition and/or contact their members of Congress promptly, explaining how the stations are important to them, beyond government and military use. WWV is among the oldest radio stations in the US and has broadcast the official time for nearly a century.

"NIST has a long-standing history of providing time and frequency services through our radio stations and we appreciate that many people use these services," NIST said in a statement. "WWV is the longest continuously operating radio service in the US. At the same time, the proposed NIST budget for FY 2019 required difficult choices about budget priorities."

NIST said that it plans to eliminate "efforts that have been replaced by newer technologies, measurement science research that lies outside NIST's core mission space, and programs that can no longer be supported due to facility deterioration."

HPARC HISTORY – HOW OLD IS THE CLUB?

How old is the HPARC? I hate to have teased you this way for so long, but the truth is – no one knows. The oldest member I knew in the HPARC when I became interested in the club's history was Mires Zett, W4TU. He knew the club was active in the late 1930's but did not know how much before that the HPARC existed.

I have in the HPARC's records a copy of a station license issued to Robert Moore acting as trustee to the HPARC. (Remember the article about Robert last month?) The club call sign was W4FYY and was issued 3/20/39. Could this be the first license issued to the HPARC? Again, no one knows for sure.

This was the original HPARC club. What do you mean "original?" Most probably don't know, but the HPARC voted to disband in 1965. Apparently attendance had fell off, and the remaining members decided to disband and sell off the club's equipment. Everything except the land the club owned. There are at least two members I know who remember the HPARC club house. Larry Frye, WA4EKD, and Tom Evans, NA4U, were fortunate enough to be a part of the HPARC back then. The HPARC owned property on Centennial Street. The club house is gone. You probably drive over the "old club house" occasionally as that property is now part of Hartley Drive.

So what happened to bring the HPARC back into existence? Next time . . .

HAMVENTION - NO NEW BUILDING FOR 2019

Hamvention and Greene County, Ohio, officials have been unable to reach agreement on erecting a new building that could accommodate Hamvention activities at the Greene County Fairgrounds and Expo Center in Xenia, Ohio.

"Hamvention/Dayton Amateur Radio Association has spent many hours working with Greene County officials to reach an agreement on a long-term contract where both the Fairgrounds and Hamvention would feel comfortable erecting a new building," read an August 5 statement from Hamvention General Chairman Jack Gerbs, WB8SCT, and Assistant Chair Rick Allnutt, WS8G. "Unfortunately, we have currently been unable to successfully reach an agreement satisfactory to all parties."

In January, Hamvention walked back

an earlier announcement that a new building would be erected in time for the 2018 show. At the time, then-General Chair Ron Cramer, KD8ENJ, anticipated that construction would be completed this year in time for Hamvention 2019.

Gerbs cited some significant upgrades accomplished in 2018, including improved tent shelters, permanent paths in the flea market area, and an additional forum room. "More improvements are planned for 2019," Gerbs and Allnutt said. "We hope the Amateur Radio community will understand and continue to support the event as enthusiastically as in the past."

LED LIGHTING INTERFERENCE TO

The US Coast Guard says it's received reports from crews, ship owners, inspectors, and other mariners regarding poor reception on VHF radiotelephone, digital selective calling (DSC), and automatic identification systems (AIS) when in the vicinity of LED lighting systems. "Radio frequency interference caused by these LED lamps [was] found to create potential safety hazards," the Coast Guard said in an August 15 Marine Safety Alert. "LED lighting installed near VHF antennas has also shown to compound the reception."

OFFICIAL OBSERVER PROGRAM TO BE RETIRED

The ARRL Board of Directors has adopted the recommendations of the Official Observer Program Study Committee, which would retire the venerable Official Observer (OO) Program and institute the Volunteer Monitoring (VM) Program. The Board instructed that the transition "be implemented as soon as practicable." Under the terms of the new program, current Official Observers will be invited to apply for appointment as Volunteer Monitors.

The Board said the action is expected to re-energize enforcement efforts in the Amateur Radio bands and was undertaken at the request of the FCC in the wake of several FCC regional office closures and a reduction in field staff. Coordination of cases and evidence gathering would become the responsibility of ARRL Headquarters staff, while the FCC will retain the responsibility for final decisions regarding action in specific cases.

SOLAR CYCLE 24 UPDATE & SOLAR CYCLE 25 FORECAST

W4HM Solar Cycle 24 Update and Solar Cycle 25 Forecast- Short and to the point.

Solar minimum may begin later this year and may last longer than any previous solar cycle in the 20th century. When solar cycle 25 finally gets underway it could be the weakest since the middle of the 19th century. Another Dalton type lesser grand solar minimum may occur with a corresponding cooling of earth's climate. This would negate anthropogenic climate change if it were occurring, which it isn't. On February 1, 2008, I forecasted that solar cycle 24 would be the smallest solar cycle in the past 100 years. That forecast verified. I also forecasted that solar cycle 25 would be almost non nonexistent.
